Procedure

Salt Fish Token Distribution





1. Out of gas

lssue:

• The function includeInReward() uses the loop to find and remove addresses from the _excluded list. Function will be aborted with OUT_OF_GAS exception if there will be a long excluded addresses list.

Recommendation

Check that the excluded array length is not too big.

Centralization

Owner privileges :

- Salt Fish Contract:
 - Owner can include in and exclude from reward.
 - Owner can include in and exclude from fee.
 - Owner can change the tax, charity and liquidity fee.
 - Owner can change the maximum transaction amount.
 - Owner can enable / disable swap and liquify.\

This smart contract has some functions which can be executed by the admin (Owner) only. If the admin wallet private key would be compromised, then it would create trouble as smart contract ownership has not been renounced.
